

## **Municipal Election 2018 (Survey Results):**

## **Township of East Zorra-Tavistock**

Poverty negatively impacts our ability to create a healthy, vibrant community. The fact that some people in Oxford County cannot afford basic needs, including nutritious and sufficient food is a real concern. In Oxford County, based on the 2015 after tax Low Income Measure, 10.8% of the population (11, 835 people) live in low income.

On September 10, 2018, all Township of East Zorra-Tavistock Candidates were contacted via email with a follow-up call and provided an introduction to, and a link to the following survey. The survey questions provide an opportunity for voters to start a discussion with candidates about poverty reduction. Our hope is that this survey serves as a starting point to an ongoing conversation about poverty in Oxford County.

Participation in the survey was voluntary. Responses provided by the candidates that completed the survey are posted and have not been changed in any way. Social Planning Council Oxford would like to thank those candidates who have completed the survey.

In my experience over the years I have served on Council work supporting this is under the direction of the Human Services Department at the County. (Paul Beaton). I have been impressed with the progress made in creating new facilities as well as improving and up-grading those we already have. If elected to EZT Council I will continue to support HS recommendations.

Candidate	<b>Position</b>	Response A	Response B
Phil Schaefer	Councillor	Unsure	The township has no public transportation, and it would be difficult to make something like this economically viable in a rural township.
Margaret Lupton	Councillor	Yes	I have often wondered if some use could be made of the many school buses that sit idle most of the day. At one time a school bus made a route from Embro to Tavistock to Woodstock in the morning and returned later in the day I wonder is something similar could be reinstated to at least help rural residents needing to access urban services but unable to access transportation to make this possible.

Margaret Lupton	Councillor	I really believe this needs to be continued under the mandate of Oxford County Human Services Department. I have confidence they have the people most able to plan the programmes that need to be implemented. I also see the need for the Province to step up their supportfinancially and other wise.
